“Star Tribune Vacation & Travel Experience” Official Rules

1. **Sponsor.** The Star Tribune Vacation & Travel Experience Sweepstakes ("**Sweepstakes**") is sponsored by Star Tribune Media Company LLC ("**Sponsor**"), located at 650 Third Ave. S., #1300, Minneapolis, MN 55488.
2. **Eligibility.** The Sweepstakes is open only to participants who, as of the entry date, are legal residents of Minnesota or Wisconsin and are at least eighteen (18) years old. The Sweepstakes is void in all other jurisdictions and where prohibited or restricted by law.
